BLAINE | FRIDLEY | SPRING LAKE PARK

On Tuesday, November 5, the Spring Lake Park Schools community will be asked to renew two levies. There is no tax increase to renew these existing levies.

Question 1 **Levy for Learning** *No-tax-increase renewal*

Question 1 is a **no-tax-increase renewal** of an expiring operating levy, or **Levy for Learning**.

- This levy funds teachers and educational support staff positions, generating \$1.28 million annually.
- This levy was first approved by voters in 2002, and was renewed in 2011.

Question 2 **Capital Projects Levy** *No-tax-increase renewal*

Question 2 is a **no-tax-increase renewal** of the expiring capital projects levy.

- This levy funds essential technology systems for classrooms, school operations and the district's safety and security systems, generating \$1.325 million annually.
- This levy was approved by voters in 2011.



Each levy is an important part of the overall budget, and allows the district to:

- maintain current programming and ongoing stability in class sizes.
- provide innovative, personalized learning and programs.
- provide for and maintain current and reliable technologies for classrooms, operations and security.

BY THE NUMBERS

The district hasn't increased the operating levy in 17 years - since 2002.

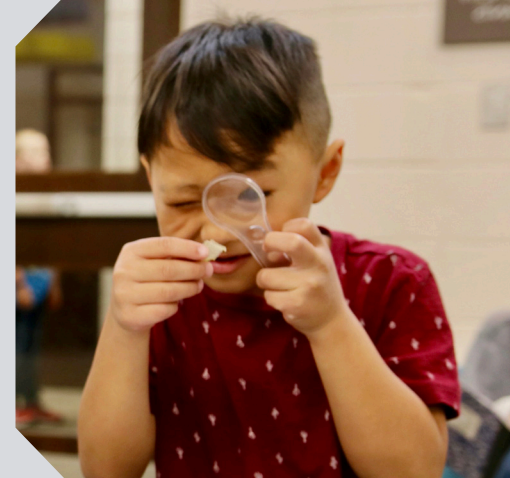

The district has received the Association of School Business Officials International's Certificate of Excellence in Financial Reporting award for 13 consecutive years.

The district's voter-approved levies are below the metro average by \$1,132 per student.

Our district's voter-approved levies rank 38th out of 40 metro school districts for amount of school taxes.

RENEWAL MAINTAINS ESSENTIALS

These levies fund essential functions throughout the district. If not renewed, the district would have to look at all operations and over time would need to make decisions that could result in actions like:

- Eventually increasing class size.
- Elimination of programs.
- Increases in walking distances to school as a result of transportation reductions.
- Increases in fees for student activities and athletics.

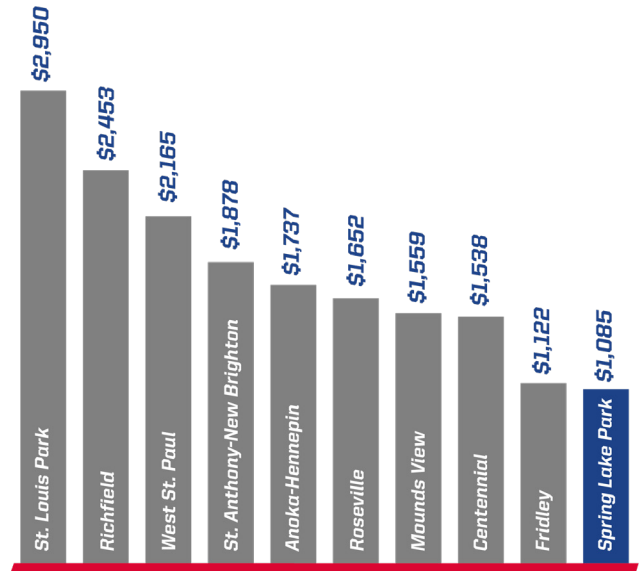
If not approved, the district would need to come to the voters again to ask for critical funding.

DID YOU KNOW?

Our Funding Requests Are Among the Lowest


Compared to other metro school districts, our funding from district residents is among the lowest.

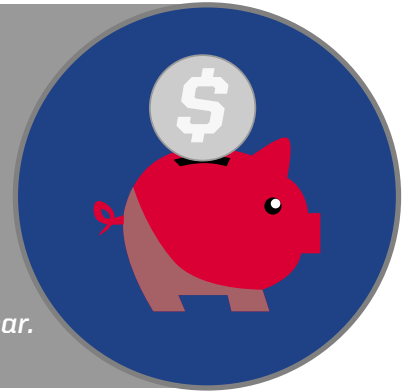
- Of 40 metro districts, 38 have approved higher funding per student through their voter-approved levies than our district.
- Our combined levies are *below* the metro average by **\$1,132 per student**.



Property Taxes Reduced by \$13 million

The SLP School Board has approved five bond refundings since 2010 that saved district taxpayers *more than \$13 million*.

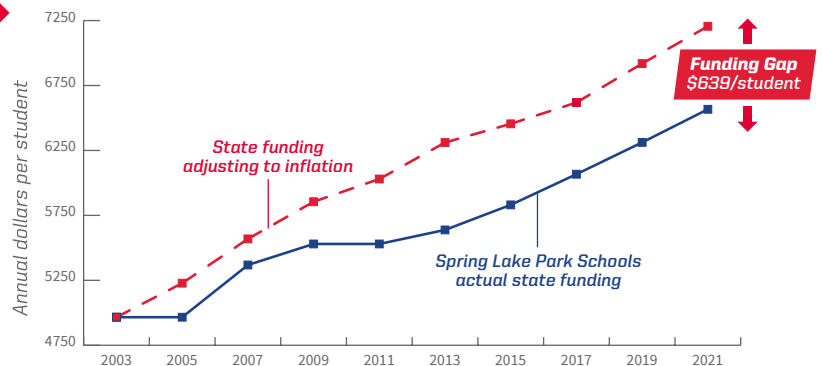

School Funding is Not Keeping Pace with Inflation

For years, inflation has grown while state and federal school funding has remained the same. If school funding had kept pace with inflation, we would have received *more than \$3.9 million* in additional funding during the last school year alone. This funding gap is projected to grow.

While the gap between inflation and funding has grown, our district has maximized its use of resources while maintaining a balanced budget and appropriate fund balance.



Levies Fund Learning, Bonds Fund Building

The levy for learning funds teachers and helps keep class sizes small. The capital projects levy funds technology for classrooms, operations and safety and security. These levies are separate from bond dollars approved in 2016. We've put bond funds to good use in our facilities, opening Centerview Elementary School last year and completing renovations at each of our schools to provide necessary, additional space, flexibility and engaging learning environments.
