Due to the Stay-At-Home order the board meeting is taking place by WebEx for the board members, with a conference call line open for the public to call in to and listen to the meeting. E. DISCUSSION, REPORTS, INFORMATION ITEMS

1. Extended Flexible Learning and COVID-19 Response Update

Chairperson Hennen thanked all staff for the work done to get extended flexible learning up and going. Dr. Jeff Ronneberg, Superintendent of Schools, reviewed the recent actions of the district response to COVID-19 and the stay-at-home order. Incredible work has been done developing the framework and guidance for teachers and staff so they have the support and quality professional learning to be and feel successful as they prepare for and engage in extended flexible learning with students.

Colleen Pederson, Director of Community Education and Outreach, shared that community education staff, nutrition services staff, building staff, bus drivers and the district partnership with the Panther Foundation are working together to deliver the district's response to providing child care for essential workers and serving meals to community children.

Dr. Hope Rahn, Director of Learning and Teaching, highlighted the partnering and extensive work taking place with and between all staff to expand the districts e-learning platform to extended flexible learning. Dr. Rahn shared the extended flexible learning guidelines for teachers and examples of strong curricular design by showing examples of student work.

Chairperson Hennen asked the board for questions and comments. Board comments and questions focused on the tech tool kit for staff and students/families, communication of staff with students/families and support of students with IEPs.

The presentation continued with Tony Mayer, Director of Student Services and Special Education, echoed the pride in the work of the student services staff in personalizing communication with families and the set up of a robust array of supports.

Dr. Ronneberg wrapped up the presentation sharing that there is a lot of good news in all that is happening, however it hasn't been without its bumps. Support is taking place behind the scenes focusing on improvement and innovation of instruction as well as in core operations of our technology, nutrition services, and facilities departments and support personnel. Dr. Ronneberg highlighted near-term, mid-term and long-term considerations, including upcoming district events currently scheduled for May and June.

Board questions and comments followed, focusing on summer school, graduation, prom, and honoring seniors.

2. <u>Superintendent's Report</u> – Dr. Ronneberg shared information regarding ACT testing, replacement of the April 24 board retreat with a work session – date yet to be determined, and review of budget considerations related to extended flexible learning. The budget will be reviewed at the next board meeting.
